Jim Dunn, former Solicitor, died Thursday at age 72 of respiratory failure resulting from Alzheimer's Disease. Jim was born and raised in Conway, the son of Otis and Tiny Burroughs Dunn, and graduated from Conway High School in 1953. That same year he joined the United States Marine Corps, serving three years including a tour of duty in Korea. Jim graduated Wofford College in 1960. He played flanker and defensive end on the Terrier's football team, and in his senior year he was selected as Captain of the team as well as Student Body President. He was also president of his graduating class from the University of South Carolina, School of Law in 1963; he was also on the South Carolina Law Review. Afterwards Jim practiced labor law for several years before finding his true calling as a trial attorney. Returning to Conway in the early '70's Jim served as Deputy Solicitor and Public Defender before being elected Solicitor in 1978. He served three terms as Solicitor for Horry and Georgetown Counties, earning reputations for both his flamboyance and his fairness. He prosecuted several infamous capital murder cases, fought for victims' rights, and once arranged a sting operation, with himself as bait, to arrest the head of a drug syndicate who had attempted to bribe him. Outside the office, Jim was the area's only known amateur shrimp-boat enthusiast. Though rarely responsible for more than a handful of shrimp, Jim's trawler the 'T-Tiny' was never-the-less a fixture on the Murrells Inlet waterfront where it did provide some ambiance. In retirement Jim devoted himself to visiting the residents of local nursing homes each day. As Alzheimer's progressed his

mind and memory began to fail him until he too had to be placed in full-time care. Jim is survived by three sons: James Otis Dunn, Jr, of Carrollton, Georgia; Rev. Jeffrey ?Jeff? Burroughs Dunn and wife Julie of Conway; and Edwin Johnson Dunn and wife Laura of Hood River, Oregon; brothers, Rev. Frank Dunn of Washington, DC and Col.Ret, Perry Dunn and wife, Evelyn of Orlando, FL; grandchildren, Ashley Dunn West, Catherine, David, Hayden, Carly and Walker Dunn; his angel, Ann Christensen of Murrells Inlet and many nieces and nephews. One daughter, Dee Dee, died in infancy. Services will be 11:00 AM, Monday at Belin Memorial United Methodist Church. Burial will follow in Lakeside Cemetery.
