Mr. Joe Perry Johnson, Jr., 81, passed away Sunday, January 28, 2024 at McLeod Seacoast in Little River.

Born November 4, 1942 in Spartanburg, he was the son of the late Joe Perry Johnson and the late Ruth Roberta Smith Johnson. Mr. Johnson was a member of Myrtle Beach First United Methodist Church and was an elder in the Presbyterian Church, USA. He was the owner of High Tech Heat, Inc. for forty years and held several patents on the Industrial Infrared Heaters and Controls they manufactured. His hobbies included membership in the Corvette Club, the Grand Strand Model Railroad Club, and Myrtle Beach Masonic Lodge 353.
