



Thomas "Skip" Murphy

Thomas "Skip" Murphy, of Surfside Beach, SC, passed away peacefully at his home on Tuesday, July 9, 2024, surrounded by his family.

Skip was born in Camp Legune, NC, a son of the late Richard and Kay (Catherine) Murphy.

Skip attended Monroe- Woodbury High School in Monroe, NY and in 1978 graduated from Buffalo University, NY after earning a Doctor of Juris Prudence. In 1979 Tom opened his law practice in Newburgh, NY, expanding to include JT Abstract Title Company. In 2013 Rich Schisano joined the firm as a partner and in 2017 Gisele Rosado joined the firm, also as a partner. In 2019, Tom retired to Surfside Beach, SC.

Skip is survived by his daughters: Maggie Cooper and Cathryn Murphy; his grandsons: Hudson and August Healy and Tommy Cooper; sisters: Karen Riley, Sherry Lundgren and her husband Kevin, Michelle Murphy; 7 nephews and 1 niece. Skip is also survived by his Aunt Mickey Jarossy and many other family members and many 1st cousins.

In addition to his parents, Skip was predeceased by his sister Patricia (Honey) McCourt.
